

Only Local Farmstead Puppy Agreement/ Health Guarantee

All puppies sold come with a minimum of their first set of shots and dewormings

Guaranteed Contract- Terms and Conditions

1. The seller will have the puppy current on vaccinations and deworming and will provide proof of dates on all vaccinations and dewormings.
2. The buyer needs to have the puppy examined by a vet of their choice within 72 hours of purchase in order to engage your 1 year guarantee. If the exam indicates at the time of sale, the puppy was unfit for purchase due to an extreme illness, disease, or congenital disorder, the buyer may return the puppy for the exchange of another puppy. However, it may have to be from a future batch. We do not refund any money for any reason. Viral and Bacterial illness is also not covered as this could be picked up from any stop along your way home.
3. The seller guarantees this puppy from fatal viruses for 72 hours from the date of purchase. This includes; distemper and parvo virus. It DOES NOT include Giardia, Coccidia, any type of worms, kennel cough, hernias, bacterial or viral infections, mange or any other minor common puppy illness.
4. The seller guarantees the puppy from 1 year of birth against fatal and life altering congenital and genetic defects which adversely affects the health of the puppy. This includes: kidney, heart and liver problems of a severe or life threatening or altering nature. Digestive issues are not covered as those can be treated with medicine or simply changes to their diet. THIS DOES NOT include any type of skin allergy or food allergy. If the dog dies within the guaranteed time frame, we do require an autopsy to ascertain the cause of death. The seller will replace the puppy with a puppy from another litter when one becomes available- if one is not already available, in the event the puppy has a genetic or hereditary defect. No refunds are given. If needed to return a puppy, shipping and all vet costs are buyers responsibility. Delivery of replacement puppies would be through the seller. If the seller replaces the puppy for any reason described above, the seller is not obligated to replace the puppy for the exact color, pattern, sex, or breed of the original puppy.
5. Seller must be notified within 3 business days of any findings of any problem. We do require one statement from a licensed vet if any issues arise. We may also ask that our vet examine the puppy/ dog. All vet bills incurred are buyers responsibility

6. If for any reason said puppy is over/ underweight or left to unkind conditions this guarantee is voided. Selling or giving away this puppy will automatically void the health agreement, guarantee is non-transferable.

7. If you can no longer keep said puppy, we reserve the right of first refusal. If we choose not to take the puppy back, we will however help find a new home for him/ her. Our puppies are to NEVER end up in a shelter or humane society of sorts for ANY reason!

8. Spay/Neuter agreement: Buyer understands that the puppy they have purchased is being sold as a pet only and must be spayed/neutered no later than 12 months of age. A copy of the spay/neuter certificate must be emailed to PoodleLovePlus@Gmail.com by the puppies 12th month. Refusal to spay/neuter will be in breach of this contract . The buyer may either purchase breeding rights at an additional \$2,800 or choose to spay/neuter the dog. If the buyer refuses to purchase breeding rights AND refuses to spay/neuter their puppy, buyer agrees to forfeit their purchased puppy back to Poodle Love Plus with no refund of any previous payments made.

9. Buyer agrees that this contract is enforceable within the courts of Carroll County Virginia.
